2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

DANGER. CORROSIVE. CAUSES IRREVERSIBLE EYE DAMAGE. CAUSES EYE AND SKIN BURNS. HARMFUL IF SWALLOWED.

Principle routes of exposure:

Eye contact: Corrosive. Causes irreversible eye damage. Causes permanent eye damage, including blindness.

4. FIRST AID MEASURES

Keep tightly closed in a dry, cool and well-ventilated place. Protect from freezing. Store in a cool, dry, well ventilated area away from heat or open flame. Keep out of the reach of children.
