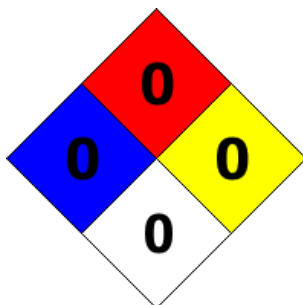

###### After inhalation:
